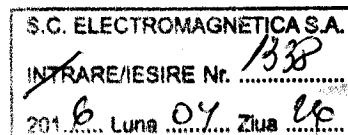

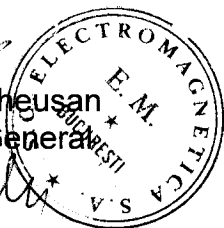
Evenimente importante de raportat: **Comunicarea deciziei de sanctionare de catre Consiliul Concurentei**

Electromagnetica SA hereby investors that on 25 April 2016 it received the decision no. 82 of 24.12.2015 issued by the Competition Council, related to a fine in amount of 9,021,308 lei imposed against our company for an alleged infringement of the law of competition on the electricity production and sales market.

As we previously communicated in our current Report of 11 January 2016, following the communication of the reasoned decision, Electromagnetica will exercise its right to challenge in court the decision of the Competition Council and will inform investors on the progress of this dispute.
