This Tender Specifications establish the principles, conditions and manner in which the sale of the goods owned by **ELECTROMAGNETICA S.A.** is to take place.

Chapter I - Tender Announcement

ELECTROMAGNETICA S.A., headquartered in 266-268 Calea Rahovei Street, Bucharest, sector 5, registered with the Trade Register under no. J1991000019408, having CUI RO 414118, (hereinafter referred to as the "Seller" or "ELECTROMAGNETICA S.A."), organizes on July 29, 2026 and August 5, 2026 at 10:00 a.m. at the address in Bucharest, Calea Rahovei, nr. 266-268, Bucharest, Sector 5, Competitive Auction opened with call (the "Auction") for **the sale of the goods described below**, which will be the subject of two Auction sessions that will be publicly announced through the newspaper, the company's website and the BVB report.

The sale is made en bloc for all the goods described in this Specifications, according to the details presented in Chapter II, and not in fractions.

Romanian or foreign individuals and/or legal entities may attend the auction meeting, provided that they are citizens or legal entities resident in European Union states, who prove that they meet the requirements set out in the Auction Organization and Conduct Regulations ("Auction Regulations"). A Tender Specifications containing the presentation of the Asset and the Auction Regulations are made available to the participants. They are available on the website of ELECTROMAGNETICA S.A., at <https://electromagnetica.ro/anunturi-licitatii-vanzari>.

The starting price of the Auction for **the goods** subject to the Auction is:

Starting price – **255,000 LEI**, to which VAT is applied according to the legal provisions, representing the value of the Assets.

The guarantee for participation in the Auction is **150,000 LEI**.

The participation fee for the Auction is **5,000 LEI** and is non-refundable.

The period of the Auction will include the following stages:

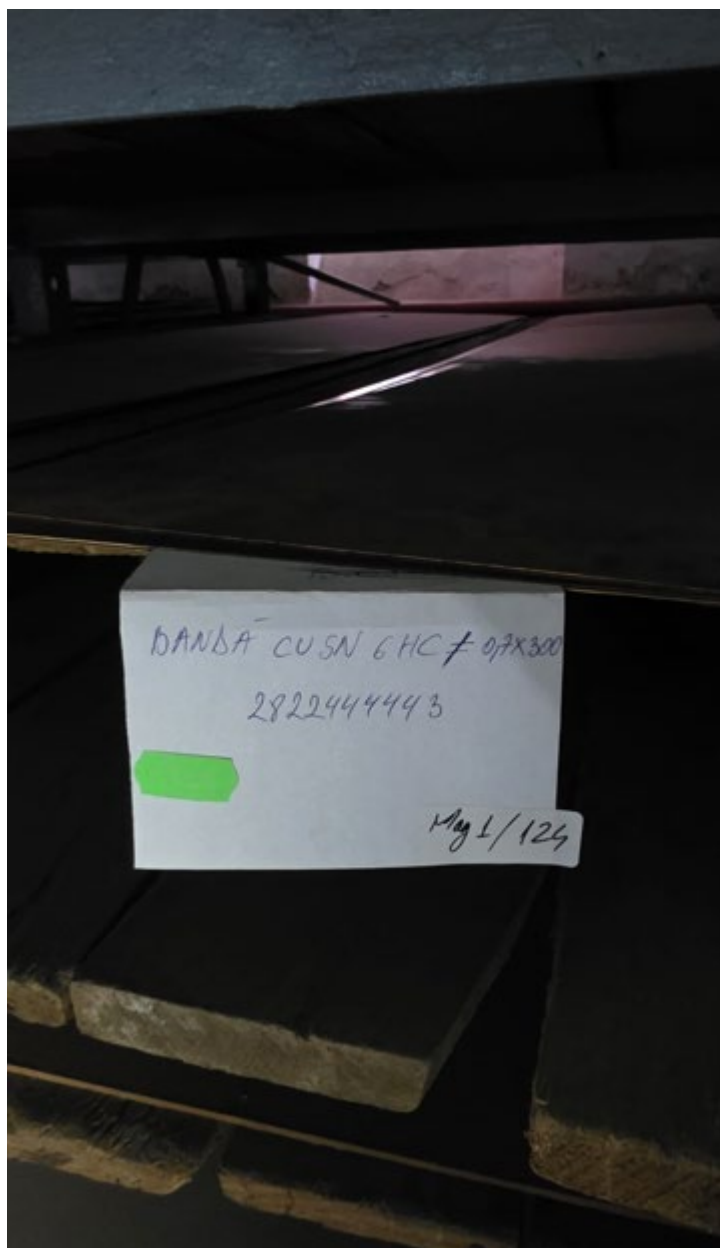

Chapter II.2 – Starting price of the Auction

The starting price of the Auction for is **255,000 LEI**, to which VAT is applied according to the legal provisions, representing the value of the Goods.

The goods are sold in the condition in which they are, en bloc, and no bids can be submitted for the partial purchase.

Chapter III. Participants and documents required for the qualification of bidders

Any natural or legal person, Romanian or foreign, who cumulatively meets the following conditions, has the right to participate in the Auction:

- paid the participation fee to the Auction (5,000 lei), including the participation guarantee (150,000 LEI);
- submitted the application for participation in the Tender, together with all the documents requested in the Tender Specifications, within the deadline provided in the Tender Specifications;
- has fulfilled all payment obligations due to ELECTROMAGNETICA S.A.;
- is not in a state of insolvency, bankruptcy or liquidation.

- 4) Proof of payment of the guarantee for participation in the Auction (in original if it was paid by cash deposit through the bank's cashier);
- 5) Declaration - agreement on the processing of personal data (GDPR) (model Annex 3.2 of the Tender Specifications);
- 6) Affidavit (model Annex 2.2 of the Tender Specifications);

- 8) Declaration of the natural persons (legal representative/representative) regarding the status of publicly exposed person (Annex 10);

- 10) Resolution of the General Shareholders' Meeting or, as the case may be, decision of the Board of Directors approving the acquisition of the Asset, which also shows that the legal representative/representative of the company has full, unlimited powers to represent the company and that the principal company assumes responsibility for all acts of the legal representative/representative, for overbidding and overbidding.
- 11) The application to participate in the auction and the bid submitted in a sealed envelope that includes the declaration of acceptance and express and irrevocable assumption of the contractual (special) conditions proposed by the draft Sale-Purchase Contract (Annex 4 to the Tender Specifications).

For foreigners, all these documents will be accompanied by a legalized translation into Romanian.

The following documents are required for representation:

In the case of the legal person represented by the company's administrator:

- **if he has full powers** , a recent ORC extract (not older than 30 days from the date of submission) is sufficient, which shows the quality of legal representative of the legal entity. A declaration of the principal company shall also be submitted stating that the company's administrator has full, unlimited powers to represent the company and that the principal company assumes responsibility for all acts of the trustee, for overbidding and overbidding, if this is not mentioned in the submitted Certificate of Ascertainment.
- **if the company's administrator does not have full powers**, he/she may submit a special power of attorney of representation on behalf of the company, signed by the representatives with full powers or a recent ORC extract (not older than 30 days from the date of submission), accompanied by a decision of the GSM empowering the company's

administrator, which will contain at least the object of the Auction in which he/she participates and the limits of his/her mandate. A declaration of the principal company shall also be submitted stating that the company assumes responsibility for all acts of the trustee, including overbidding and overbidding.

- **In the case of a representative other than the legal representative**, the special power of attorney signed by the representatives with full powers shall be submitted, as well as the proof of the full powers of the signatory of the power of attorney. The special power of attorney will contain the mention that the principal assumes responsibility for all the acts of the agent, including overbidding and overbidding.

The Auction Organizer reserves the right to request additional documents to prove representation.

The absence of any of the documents listed above or their presentation in violation of the conditions mentioned above, by the deadline for submission of documents for individuals or legal entities, entails automatic disqualification (exclusion) from participation in the Auction and exclusion of the bid.

The process of selling the **Goods** will comprise two stages:

1. Designation of the successful bidder/buyer **of the goods**.
2. Conclusion of the Sale-Purchase Contract.

The persons who are part of the management of ELECTROMAGNETICA S.A. and the persons with decision-making positions within ELECTROMAGNETICA S.A., involved in the sale procedure, in consideration of which the bidders must evaluate and declare the non-existence of the conflict of interest are the following:

Chapter IV. Contractual clauses

In order to transfer the ownership of **the goods**, the related Sale-Purchase contract ("Sale-Purchase Agreement", in the form annexed to these Specifications, as Annex 4.1) shall be concluded.

The price will be paid in full until the date of signing the Sale-Purchase Agreement.

Each of the bidders has the obligation to independently carry out, on their own account and on their own responsibility, an analysis of any mandatory legal conditions for the valid conclusion of the Sale-Purchase Agreement and the transfer of ownership of the Goods. If the fulfillment of such conditions proves necessary, the Sale-Purchase Agreement will be amended exclusively to the extent necessary to reflect the obligation to meet these conditions, to the full satisfaction of the Seller.

The parties will conclude the Sale-Purchase contract within 10 working days from the signing of the award report, and the transfer of ownership of **the goods** will be made within 5 working days from the date of conclusion of the sale-purchase contract under the condition of payment of the full price.

Potential bidders have the right to inspect and investigate the goods, under the conditions of this Tender Specifications and the Regulation, and agree to purchase the goods as they are, on the principle of "as is, where they are", assuming this situation, as well as the obligations imposed in this Tender Specification.

All costs related to further investigation and/or expert reports are borne by the bidder.

The Sale-Purchase Agreement will be signed with the successful bidder, based on the approval decisions of the competent management bodies of the successful bidder, as the case may be, and of ELECTROMAGNETICA S.A.

Chapter V. Guarantee of participation in the Auction

In order to protect the seller from the risk of inappropriate behavior of the auctioneer during the Auction and until the conclusion of the Sale-Purchase contract, ELECTROMAGNETICA S.A. requests a guarantee of participation in the Auction ("Guarantee"), under the following conditions:

	The guarantee is refunded starting with the first working day following the resolution of the appeals or after the expiry of the deadline provided in the documentation for submitting appeals, if no appeals are registered. In the case of the successful bidder, the Guarantee is considered as an advance from the sale price and is deducted from the amount due for the sale of the goods.
Loss of warranty	The warranty is lost if: ▪ the bidder/bidder did not show up at the Auction and/or, although it did show up, did not offer at least the starting price for that Auction; ▪ the bidder/bidder who won the Auction does not sign, for any reason, the Sale-Purchase contract, or does not pay, for any reason, the value of the goods within the term established by the Tender Specifications and the Auction Regulations; ▪ the winning bidder/bidder revokes the bid after the award; ▪ other cases provided for in these Tender Specifications or the Sales Regulations.

The guarantee for participation in the Auction in the amount of 150,000 LEI is deposited by bank transfer to the IBAN RO93BTRLRONCRT0317847001 account, opened by ELECTROMAGNETICA S.A. at Banca Transilvania, by payment order.

Bidders declare that they participate in the Auction in full knowledge of the facts and know that each Bid is unconditional, irrevocable and unrestricted. Through the bidding operation, the bidder:

- **fully accepts these Tender Specifications and the Tender Regulations, including the Sale-Purchase Agreement (Annex 4.1. of the Tender Specifications);**
- **undertakes to purchase the Auction Object at the price it has offered, under the conditions of this Tender Specifications and the Auction Regulations;**
- **undertakes to bear, if necessary, the costs of the deployment, loading and transport of the goods.**

The successful bidder of the Auction Object will sign the "Award Report" of the Auction on the date of the Auction and will pay the price within the established term. Otherwise, the guarantee of participation in the Auction will be retained, as damages, in the patrimony of ELECTROMAGNETICA S.A.

All potential buyers, Romanian or foreign individuals or legal entities, who comply with the provisions of this Tender Specifications and the Tender Regulations and whose documentation has been declared compliant, have unrestricted access to the Auction meeting.

In order to participate in the Auction, potential entitled buyers will be notified no later than 12:00 on the day prior to the Auction. The notification will be made by email, to the address indicated by the respective potential buyer.

Chapter VI – How the Auction is conducted

- (1) The auction shall be held on the date, place and time indicated in the announcement.
- (2) The auction shall be conducted in one or more bidding stages, under the conditions established in the Auction Regulations.
- (3) The identification and qualification of the participants in the Auction shall be made according to the conditions of participation and the "Qualification Documents" (mentioned above).
- (4) It is mandatory that all Bidders present offer at least the starting price of the Auction. By registering and participating in the Auction, the bidder(s) is deemed to provide the starting price of the Auction. The Auction will also be held in the presence of a single bidder, who is considered to bid at least the starting price of the Auction by participating in the Auction.

The auction is coordinated by an Auction Commission with the following attributions:

- conducts the Tender meetings, in accordance with the provisions of the Tender Specifications and the Tender Regulations;
- verifies and analyzes participants' documents;
- draw up the list of accepted participants, excluding from participation those who do not meet the conditions;
- announces the conduct of the Auction, clarifying any doubts;
- announces the starting price of the Auction; the bidders announce by shouting and picking up the participation slip, a price equal to the one announced by the organizer or a price better than the starting price of the Auction, in accordance with the Auction Regulations;
- establishes the tiebreaker of the bidders, at equal price offers, in accordance with the provisions of the Auction Regulations;
- announces the winner of the Auction, declares the Auction meeting closed, draws up the auction minutes signed by the members of the Auction commission and the participants in the Auction;
- resolves any disputes regarding the result of the Auction within 5 working days from the date of their submission to the Seller.

Appeals regarding the result of the Auction can be submitted to the organizer's headquarters, where the Auction took place, within a maximum of 2 working days from the date of award, with the explicit presentation of the arguments based on documents. The annulment of the sale procedure is not contested.

The minutes of the Auction will include:

- a. the Announcement, the Tender Specifications and the Tender Regulations (as annexes);
- b. List of bidders;
- c. The criteria for evaluating the bids in compliance with the provisions of the Tender Regulations;
- d. The steps/prices called by the bidders and the result of the Auction, with the indication of the winner;
- e. Agreements for the processing of personal data signed by all bidders (as annexes);
- f. The particulars, as the case may be, provided for in the Regulation.

Chapter VII. Conditions for participation in the Auction

In order to participate in the Auction, bidders must meet the following conditions:

- a. to provide the Guarantee and submit all required documents;

b. to be declared qualified, based on the required qualification documents.

The Announcement, the Tender Regulations and the Tender Specifications for the Auction will be posted on the website of ELECTROMAGNETICA S.A., at <https://electromagnetica.ro/anunturi-licitatii-vanzari>.

Chapter VIII. Bid evaluation criterion

Bid evaluation criterion: in accordance with the provisions of the Tender Regulations.

Chapter IX. Other details

The final decision on the sale **of the goods** to the winner of the Auction will be taken by the management bodies of ELECTROMAGNETICA S.A., according to the decision-making powers, within a maximum of 2 (two) working days from the date of resolution of the appeals or the expiry of the date of submission of the appeals. The Sale-Purchase Agreement will be signed with the successful bidder within 10 working days from the date of signing the award report.

ELECTROMAGNETICA S.A. will ensure the necessary conditions for the transparency of the Auction process for the sale of **goods**, by setting up a section on www.electromagnetica.ro's own website, called announcements-auctions-sales.

Chapter X. Cancellation of the auction

The advertisement for the organization of the Auction, as well as the completion of the stages of the Auction, does not create the obligation for ELECTROMAGNETICA S.A. to carry out the respective sale or to conclude the Sale-Purchase Agreement.

ELECTROMAGNETICA S.A. may cancel/terminate the sale procedure at any time until the moment of signing the award report, without any obligation to inform the bidders of the reasons that determined the cancellation of the sale procedure, but it will communicate the cancellation decision in writing to all participating bidders and will fully return the participation guarantees.

In the event that the cancellation of the Auction is made after the award, because the winning bidder does not conclude the Sale-Purchase contract within the agreed term, ELECTROMAGNETICA S.A. will retain the Guarantee of the winning bidder to cover the damage created by the failure to conclude the Sale-Purchase contract.

Chapter XI – Appeals and disputes

The appeals will concern only the result of the Auction and can be submitted to the headquarters of ELECTROMAGNETICA S.A. within a maximum of 2 (two) working days from the date of conclusion of the Auction Award Report and must include all the reasons that were the subject of the appeal with the explicit presentation of the arguments based on documents.

The contesting bidder will receive a written response to the appeal submitted within a maximum of 5 (five) working days from the date of registration of the appeal. Only appeals registered within

the aforementioned deadline will be taken into account and only for reasons related to the outcome of the Auction.

Bidders who have not bid, who have withdrawn, who have lost or withdrawn their participation guarantee during the validity period of the guarantee will not be able to appeal based on the above provisions.

Chapter XII. Conclusion of the Sale-Purchase Agreement

The contract is concluded within 10 working days from the date of signing the award report, in compliance with the provisions and conditions of Chapter IV above. The seller will inform the successful bidder within 2 working days from the date of resolution of the appeals or the expiry of the date of submission of appeals regarding the date of signing the Sale-Purchase contract.

The transfer of ownership of **the goods** will be made at the time of full payment of the award price.

The deposited guarantee is retained by ELECTROMAGNETICA S.A. as an advance from the sale price and is deducted from the amount due for the sale **of the goods**.

If the successful bidder fails to appear for the signing of the Sale-Purchase Agreement within 10 working days from the date of signing the award report, on the date and place indicated by the seller or, although he or she presents himself, refuses to sign the Sale-Purchase Agreement and/or any documents necessary to give full effect to the transaction envisaged by the Sale-Purchase Agreement, he loses the quality of successful bidder and the guarantee. In this case, ELECTROMAGNETICA S.A. has the right, at its choice, to:

- invites qualified bidders to the Auction, in descending order of ranking, in order to conclude the Sale-Purchase Agreement, but who meet the price conditions requested by ELECTROMAGNETICA S.A. In this case, the term of validity of the Guarantee and the Offer will be extended or, for the bidders who have requested and received the Guarantee back, its constitution will be renewed;
- cancel the Auction and resume the sale procedure.

The auctioneer declared the winner is obliged, under penalty of losing the Guarantee, to pay in full the awarded price within the agreed term, according to the method established in the Sale-Purchase Agreement.

By participating in the Tender, the bidders have acknowledged and fully accept the conditions of its conduct mentioned in this Tender Specifications, which comprises 44 pages.
